- 2.1. Astro PFP FR Putty Seal, is supplied in Ø 15mm cord for service penetrations, 4mm pads for electrical and tap water sockets.
- **2.2.** In accordance with article 11(4) all products are supplied with product code, date of manufacture and with all manufacturing processes traceable through Astroflame's factory production controls (FPC) held in the product technical files.
- **3.** Intended use or uses of the construction product, in accordance with the applicable harmonized technical specification, as foreseen by the manufacturer, and in accordance with the applicable European Assessment Document: EAD 350454-00-1104 (penetration seals).
- **3.1** Astro PFP FR Putty Seal is a flexible pad or cord used to reinstate the fire resistance performance of wall and floor constructions where they have been provided with apertures for the penetration of services, conduits or cables into socket boxes.
- **3.2** The specific elements of construction that the system Astro PFP FR Putty Seal may be used to provide a penetration seal in, are as follows:

Flexible walls: The wall must have a minimum thickness of 100 mm and comprise steel studs lined on both faces with minimum 2 layers of 12.5 mm thick boards.

Rigid walls: The wall must have a minimum thickness of 100 mm and comprise concrete, aerated concrete or masonry, with a minimum density of 650 kg/m3.

Rigid floors: The floor must have a minimum thickness of 150 mm and comprise aerated concrete or concrete with a minimum density of 650 kg/m3.

The supporting construction must be classified in accordance with EN 13501-2 for the required fire resistance period.

- **3.3** The provisions made in the UK Technical Assessment, 0843-UKTA-23/0025 and in the European Technical Assessment, 21/0026 are based on an assumed working life of the Astro PFP FR Putty Seal of 50 years, provided that the conditions laid down in the manufacturer's datasheet and instructions for the packaging / transport / storage / installation / use / repair are met. The indications given on the working life cannot be interpreted as a guarantee given by the manufacturer, but are to be regarded only as a means for choosing the right products in relation to the expected economically reasonable working life of the works.
- 3.4 Type Z_2 : Intended for uses in internal conditions with humidity lower than 85 % RH excluding temperatures below 0 °C, without exposure to rain or UV.
